VISITORS TO OUR WEBSITE

Analytics

When you visit www.safeschoolsallianceuk.org we use a third-party service, Google Analytics, to collect standard internet log information and details of visitors behaviour patterns. Cookies

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. This information is used to track visitor use of our website and to compile statistical reports on website activity.

Purpose and legal basis for processing

The lawful basis we rely on to process your personal data is either Article 6(1)(a) of the GDPR, for example when we require your consent for the optional cookies we use, or Article 6(1)(f) which allows us to process personal data when it's necessary for our legitimate interests. For example, in order to maintain the integrity of our IT systems and the continuity of our business.
